## Programme Overview

The Sijil Kemahiran Malaysia is a certificate issued by the Department of Skills Development (JPK) of the Ministry of Human Resources for cosmetology and beauty skill programmes. The programme is suitable for all age groups of people who have a deep interest in the field of beauty and want to make it a career after graduation. It is specially designed by beauty industry experts to nurture students with solid aesthetic-service knowledge and skills that emphasise hands-on practical learning of face and body treatments. It fulfils the requirements of the beauty industry by incorporating subjects such as workplace safety, hygiene and maintenance, services consultation, facial manual and electrotherapy services, superfluous hair depilation/lightening services, and manicure and pedicure services, with soft skills embedded into the curriculum.
